Proposal No. 4

UNPAID DUES - LOSS OF MEMBERSHIP **PASSED**

One-Time-Waiver for all past Members who have lost their Membership (struck off) for not paying their Dues (Subscription or Any Other Dues) during the period 31st March 2020 to 30 September 2021. They be given an opportunity to re-apply for membership.

The above proposal is valid till 30th September 2022.

RESOLUTIONS PROPOSED BY THE MANAGING COMMITTEE

TEMPORARY MEMBERSHIP

PASSED 4.9

Membership is open to Individuals, along with their spouse & children up to the age of 18, for a period of 3 years, and renewable for another 3 years only (for Temporary Members who have applied for Permanent Membership), at a rate approved at the AGM. Normal monthly Membership fees, nonutilisation fees and all statutory payments shall be applicable.

SUBSCRIPTION AND DUES

PASSED 7.9

A Member shall spend a minimum of Rs.300 per quarter in the Cafeteria or Bar, falling which the shortfall will be collected as 'Non-Utilisation Fee' (NUF). Privileged Senior Citizen, Senior Citizen, Senior Dependent below 24 years, Term of Office and Honorary Members are exempted for payment of NUF.

PASSED7.10

The periods of calculation of non-utilization for the quarters will be 1st July to 30th September, 1st October to 31st December, 1st January to 31st March, and 1st April to 30th June.

DUTIES & POWERS OF THE MANAGING COMMITTEE

PASSED 10.3.6

In the unlikely situation where the Treasurer will not be available for a period in excess of 1 month, the Managing Committee shall nominate the PFC Chairman as Treasurer for signing of cheques for the period during which the Treasurer is not available.

DECORUM COMMITTEE

PASSED 16.1

The Decorum Committee shall consist of two Gentleman Members and one Lady Member to be appointed by the General Body at an Annual General Meeting.

PASSED_{16.2}

Only Senior Members of the Club who have served at least for a period of one year as an Office Bearer of the Club shall be eligible to be appointed as its Members. The above prerequisite does not apply for the Lady Member of this Committee.

DUTIES & POWERS OF THE MANAGING COMMITTEE

PASSED_{16.3}

The duration of a post as a Decorum Committee member shall ordinarily be three years. Retirement of a Decorum committee members shall be in rotation i.e. One members retires every year and shall be eligible for re-appointment after a break of two years. Notwithstanding what is herein contained, if there are any pending matters before the Decorum Committee, the same shall be completed prior to them demitting the Office.

MEMBERSHIP STRENGTH

PASSED

The number of permanent Members (Patron, Donor, Life and Ordinary) shall not exceed 3,650 by June 2023, 3,800 by June 2024 and 3,950 by June 2025. The number of Associate Members (non-Voting) shall not exceed 365 by June 2023, 380 by June 2024 and 395 by June 2025.


